Ten years ago, we started Results for America with a simple idea:

Governments that harness the power of evidence and data would make better decisions and faster progress on our toughest challenges.

Ten years later, we are seeing the results: **Billions** of federal dollars shifted to more effective solutions. **Millions** of people across the country benefiting from more results-oriented government decisions. **Thousands** of high-impact government leaders – at every level – delivering for residents.

For the last decade, we have helped government leaders test new strategies for using evidence and data to increase the impact of government dollars. Through this work, we have refined an approach that steers more public dollars to solutions that accelerate economic mobility.

Our mission for the next 10 years: To spread this approach far and wide. To close racial gaps and open opportunities for all. To work with leaders across the political spectrum to improve the impact of the over \$2 trillion already being spent each year by governments in the United States to meet the needs of vulnerable populations and advance economic mobility.

Big solutions don't have to be partisan or political. By investing in what works, we can help restore the public's faith in government's ability to tackle our most difficult problems.




Flow of Investment

AmeriCorps

In 2013, Results for America began urging federal agencies to prioritize evidence of effectiveness in their grant programs through the annual Invest in What Works Federal Standard of Excellence. AmeriCorps was among the first agencies to respond, and it has <u>increased</u> its evidence-based grantmaking every year. Last year, 51% of AmeriCorps' State and National grants went to programs backed by strong evidence.



THE IMPACT

This shift helped Minnesota Reading Corps – which improves reading skills for K-3rd grade students, according to multiple rigorous studies – receive \$7 million more from AmeriCorps over five years. The program was able to add 400 more tutors and serve 6,000 more students.

Nevada

Nevada state education leaders worked with Results for America to seize on the evidence provisions in the bipartisan federal education law (Every Student Succeeds Act) to steer over \$200 million in both federal and state grants annually toward programs backed by evidence.



THE IMPACT

In one school – Grass Valley Elementary School in Winnemucca, Nevada – this shift to evidence-based interventions <u>nearly doubled</u> the number of 3rd graders who were proficient in reading in a single year.

Guaranteed Income

In 2020, Results for America led a "Solutions Sprint" for 22 cities that wanted to learn more about how to implement a "guaranteed income" program. A rigorous evaluation of Stockton, CA's program – which provided monthly cash transfers to struggling residents – found that recipients were twice as likely as non-recipients to find full-time employment, while also experiencing other benefits, such as reduced depression and anxiety.



THE IMPACT

After the seven-week Sprint, half of the cities (11 cities) launched or announced plans to launch Guaranteed Income pilots. Tacoma (WA) Mayor Victoria Woodards said the Sprint helped her city secure \$500,000 in additional funding and "develop a successful pilot...[and] implement the program in an accelerated fashion."

Racine

For decades, Racine had one of the highest unemployment rates in Wisconsin, as well as low educational attainment rates, with roughly one in five adult residents lacking a high school diploma or equivalent. In 2019, the city was selected to participate in Results for America's What Works Cities Economic Mobility Initiative, designed to help Mayors test strategies and work more closely with community partners to increase economic mobility.



THE IMPACT

Racine's High School Equivalency Diploma program – led by YWCA Southeast Wisconsin – had generated strong results but was serving only a small number of participants. With the added capacity, the city expanded the program, added community partners and secured additional federal and state grants. Over 400 students have now completed the program – with 80% having graduated and earned workforce readiness certificates – positioning themselves for better wages and higher quality jobs.


